M/s Nouveau Jewellery LLP, Unit No. 406 on Plot No. 248, 206-207-A, 36-39 & 48-51, Surat SEZ vide their letter dated 19.09.2022 has requested for inclusion of Plot No. 222 in their existing LOA dated 18.03.2020 as amended from time to time. They have also submitted a copy of letter of earmarking vide letter dated 06.06.2022 admeasuring 1000 Sq. meters issued by the DGDC Ltd in this matter for extension of their project at the said plot.

The unit has requested that they urgently need approval for addition of the said premise so that they could obtain all necessary permission to begin activities. Therefore, the Development Commissioner has considered the request and grant approval for addition of the said plot in their existing LOA subject to the fulfillment of other standard terms and conditions.

Hence, the matter was put up before the Approval Committee for post-facto approval. After due deliberations, the Committee give the post-facto approval.
